Patty Dautremont Johns, L.Ac. attended the Colorado School of Traditional Chinese Medicine where she graduated in 2000 with a degree in Traditional Chinese Medicine. She is National Board Certified in Acupuncture by the National Commission for the Certification of Acupuncturists and Oriental Herbolgy (NCCAOM), registered as an acupuncturist by the state of Colorado and is a member of the Acupuncture Association of Colorado. Her specific training includes 3 academic years of western and oriental medical sciences at the Colorado School of traditional Chinese Medicine. This included training in the recommendation and application of adjunctive therapies and Chinese Herbal Medicine, as defined by traditional oriental medical concepts.
